		Mr Visha	nirman Mr Sumit Chhabra presided the meeting in absence of Chairman al Dhingra. In his welcome note, Mr Chhabra welcomed and thanked to ber of the General Body present for attending the 9 <sup>th</sup> AGM, and asked & Election Committee to proceed further with agenda.		
03:10 PM	9.2		ng Body Election process, nominations, and results of election by Returning Officer (RO) – CA Mr Vikas Goyal, EPCH		
		9.2.1	Mr Manoj Rana, member of Election Committee, introduced Mr Vikas Goyal as RO who explained the election process. He shared with the member body that the Election committee followed all rules laid in the election process that were circulated to members.		
		9.2.2	Returning Officer (RO) CA Mr Vikas Goyal from EPCH, explained the process followed during scheduled election timeline. He shared that 3 member panel for Election Committee included the 3 non-contesting members of GB, namely Mr Vishal Dhingra, Mr Manoj Rana, and Mr Vishal Narain Sinha.		
		9.2.3	He further Informed, that announcement of election rules, schedule and AGM date was communicated to all members with date of election as 24th June 2025, and AGM on 26th June 2026.		
		9.2.4	Mr Goyal updated that there were 19 nomination forms received out of which 1 was not considered due to delayed receipt. 12 forms were incomplete as endorsement were not enclosed as mentioned in the Election Rule and only 6 forms were found correct and in order of election rules and nomination procedure.		
		9.2.5	Member Mr Anuman Sharan, & Mr Sonal Saggi raised their concern on the 12 incomplete forms and questioned on it. EC member Mr Vishal Narrain Sinha shared that after receiving all applications, the EC was asked by Mr Vishal Dhinga to change the rule and accept the forms but that was not possible as EC could not change in rules after initiation of the Election process. However, RO had suggested to allow 2 hour window to submit the complete forms but which could not be done due to delay in EC coming to a common ground and lack of confirmation by

			next day so the RO could not open the window beyond working hrs.
		9.2.6	Mr Manoj Rana, EC member, stated that last attempted elections during
			Feb 2025 were null and void due to errors made and rules that were not
			followed. BAA secretariat was asked to get confirmations on
			endorsement which was not the correct way of conducting elections as
			Secretariat cannot be involved in execution of the election process.
			Given the last election failure, the EC was very particular in ensuring that
			all rules were followed.
		9.2.7	Ms Christine Rai, FM and former chair, mentioned that since BAA is still
			a very young organization and learning as we go, even process
			documents needs improvement and she suggested members
			collaborate to make necessary improvement to the election process
			document also so that we don't face any such questions in the future.
		9.2.8	RO confirmed that 6 correct forms were received against the vacant
			positions of 8 in Members category. In Founder Member category, only
			1 correct form was received out of 3 vacancies. Hence voting process
			was not needed as no of eligible nominations was less than no of seats
			available.
		9.2.9	Members questioned on why the AGM was not postponed. Mr Manoj
			Rana shared that as per Societies Act. AGM once announced cannot be
			canceled or postponed unless there is an emergency or lack of quorum.
			Hence, AGM needed to take place and changes that are needed in
			process, can be executed by the new GB in consultation with the
			Members.
		9.2.10	RO shared the names of the 6 appointed new members of GB and
			matked the completion of the election process
